Irving R. Stubbs Family

In 1991, I, Irving R. Stubbs, suggested to my sister, Jane Stubbs Bailey - 1934-2008, that she might wish to explore the roots of our family. Words to epitomize her investment in that mission would trivialize the adventure she embraced with passion.

(Check out our website for my Tribute to Jane Stubbs Bailey.)

Her background in history and library science and her love for our family equipped her to carry out this mission with professionalism and enthusiasm. She engaged a network of cousins and colleagues that added many levels of depth to her research. She invested time and capital and a bottomless well of energy to this quest. Her mentor, Robert Stubbs, a forensic chemist, gave her very helpful professional guidance.

Ovarian cancer invaded her life. Nevertheless, she persisted in her commitment to dig deep in our genealogy and brought it to a well-documented turning point that moved us from informal anecdotal memories to a seriously researched database for our emerging genealogy.

John, Jane's husband, delivered to me about 30 file boxes of materials containing Jane's 15-year collection. He also transferred to me 250 email exchanges between Jane and her genealogical network. These emails and my own 250 from Jane, contained where Jane had arrived in her research and the relationships and communications she experienced in pursuit of that research. In November of 2008, I published a collection of Jane's findings with the title, "Long Live the Stubbs" – her phrase.

Additional DNA findings and a few new pieces of data provide this update that is included on our website. Jane's son, Brian Bailey, developed an earlier site that focused on our family that landed in North Carolina. The findings of Jane Stubbs Bailey, Robert Stubbs and Irving R. Stubbs follow.

According to Robert Stubbs, the most recent common ancestors for Stubbs-Everett and Stubbs-Minor were each born in the 1690's. The Stubbs surname is at least eight centuries old and as a place name in Yorkshire is likely over 1000 years old. Cheshire has some of the largest numbers of Stubbs in England. There are many references to several Richard Stubbs during the 1600's. Jane (of the Stubbs One Name Project) with whom Jane Stubbs Bailey was in contact, suggested the Nantwich area Stubbs as a focus for research.

A Family Tree DNA shows a strong match for Irving to Richard Stubbs, b.1678 d.1704 likely in Cheshire, England. Rodney R. Stubbs and Irving have a Family Tree DNA FF Big Y STR difference of only 2 of 410 and a genetic difference of 2. Gordon Mottershead and Irving have a Family Tree DNA FF Big Y STR difference of 3 of 374 and a genetic difference of 9.

(Rodney Stubbs and the Gordon Mottershead family profiles are included on our website.)

The first ancestor of a Cheshire relative to leave England may have been Richard Stubbs, born 30 July 1823 in Northwich, Cheshire, England. He settled in Provo, Utah. He gives as his father Samuel Stubbs, born 18 December 1800 in Castle, Northwich, Cheshire, England. He gives as Samuel's father Richard Stubbs, born 29 May 1762 in Stanthorne, Davenham, Cheshire, England. He gives as Richard's father Matthew Stubbs, born 1731, Davenham, Cheshire.

A Stubbs family from Utah was tested at smgf.org. The results were an exact match with Irving. The Utah family had more recently immigrated (ca 1840's) to the U.S. This family has family and christening records showing they were from Cheshire, England. The earliest known member of this family was Matthew Stubbs, christened 18 Feb 1728, in "Acton by Nantwich, Cheshire, England." The DNA results for Irving, are an exact match (at the 34 markers they share in common between FTDNA and smgf.org) with those of this Matthew Stubbs christened 18 Feb 1728, Acton, by Nantwich, Cheshire, England. (Robert Stubbs references a later Matthew Stubbs born ca 1825-1835.)

Assuming the Matthew Stubbs pedigree at Familysearch.org is correct; this shows a likely ancestral connection for the Stubbs-Everett and the Shadrach Stubbs' families. Robert reports that there are several references to Matthew Stubbs born in Cheshire in Familysearch.org. and that it is reasonable to believe that our Stubbs-Everett line is also from Cheshire.

(Acton is a small village and civil parish lying immediately west of the town of Nantwich in the unitary authority of Cheshire East and the ceremonial county of Cheshire, England according to Wikipedia.)

Todd Stubbs in Utah is a descendant of this family. This is the basis for our current belief that the families of Thomas Stubbs and Mary Everett, Shadrach Stubbs of NC, and the family of Richard Stubbs of Hull, MA, likely all have a common ancestor in Cheshire, England.

(More about the Todd Stubbs family is included on our website.)

A New England Stubbs family descends from Richard Stubbs b ca 1619, England, who came to Hull, MA ca 1650. This family is also closely related to that of Thomas Stubbs (1695-1738) and Shadrach Stubbs of NC. The families of Thomas Stubbs and Mary Everett, Shadrach Stubbs of NC, and the family of Richard Stubbs of Hull, MA, likely all have a common ancestor in Cheshire, England.

There is a Richard Stubbs who signed a petition in 1708 in Hyde County, NC. Given the date 1708 when Thomas would have still been underage, it may indeed be that the father of Thomas and, also the ancestor of Shadrach, was Richard Stubbs of Hyde Co.

Jane searched Richard Stubbs (1650-1775), at familysearch.org using the "International Genealogical Index" which has transcriptions from many Cheshire parish records. Two early Richard Stubbs are in "Acton, By Nantwich", Cheshire, England. They are: Richard Stubbs b 11 Jan 1654, Christened 9 Mar 1654, Acton By Nantwich, Cheshire, England, son of John Stubbs. Richard Stubbs b 17 Feb 1656, Acton by Nantwich, was the son of Edward Stubbs.

Jane wrote that a Richard Stubbs, according to Ethel Farrington Smith in her "Early Families of Hull, Massachusetts' was born in England about 1619 and died in Hull in 1677. It is tempting to think that the son of Richard Stubbs of Hull may have gone to Hyde Co, NC. Jane checked with Marjorie Stubbs Heaney a genealogist of the Hull, MA Stubbs family, and author of a book about Richard Stubbs of Hull MA. According to Marjorie, Richard's son also named Richard (1661-1710) was born and died in Hull, MA. She said that all of the Stubbs males in that time period (ca 1708) are accounted for and therefore she doesn't believe that any of them went to NC.

Robert: Regarding the Stubbs in Hull MA; one of our Stubbs DNA Project members had indicated that he was a descendant of Richard Stubbs of Hull. Since his DNA was a close match with Stubbs Everett, it was likely that both lines shared a common ancestry.

Our earliest proven Stubbs ancestor is Thomas Stubbs who first appeared in 1720 in what was then Chowan Precinct now Washington County, NC.

Thomas married Mary Everett around 1720 or 1721 and they had 5 sons and 3 daughters. **We descend from their son Thomas Stubbs (II), born around 1723 and died around 1800.** Thomas Stubbs (I) died in Beaufort County between January and March 1738. His wife Mary died August 17,1738 in what was then Tyrrell County but is now Washington County, North Carolina. Mary's father, Nathaniel Everett, became guardian of the Stubbs children.

How Thomas Stubbs got here and purchased land in 1720 was unknown to Jane. She searched Virginia records and even New England records without finding an earlier mention of him.

The next 5 paragraphs are from Robert Stubbs.

The Stubbs families to date are in four distinct DNA clusters, Stubbs-Everett Stubbs-Minor Stubbs-Cappahosic, Gloucester, VA Stubbs, Joel, GA. Each of these four has a genetic distance of 15 or more from each of the others, indicating they are not closely linked to each other. Participants within the Stubbs-Everett are much more closely related to each other, having a genetic distance of 4 or less from their ancestral modal value.

We may find that the New England Stubbs form a fifth distinct cluster, or that they are close to one of the other four, or that they are somewhere in between. The four Stubbs families only go back 250-300 years. The most recent common ancestors for Stubbs-Everett and Stubbs-Minor were each born in the 1690's. Therefore, if Stubbs do share a remote common Stubbs ancestor, the genetic distance between those Stubbs descendants may well be much more than the 4 or so which developed in two or three centuries.

It would seem possible that a genetic distance of 15 would be consistent with a common ancestor over 800 years ago, although this may not be the statistically best answer. However, there are some constraints which we can place on possible common ancestry.

The S21 mutation which defines the haplogroup R1b1c9* is thought to be 8 to 10 thousand years old. Stubbs-Minor is S21+. Stubbs-Everett is waiting for results, but having a value of DYS492=13 means that there is about a 95% chance that this family is also S21+. Stubbs, particularly in 1881, were primarily in the northern (former Danelaw) counties of England.

I have copies of letters of William A. Stubbs written in January 1875 in Cuthbirth, Georgia to his son George W. who was living in Blanco, Texas, and George W. Stubbs to his son William Hamp living in Dripping Springs that was written in October, 1904 in Cranfills Gap, Texas. I also have chapter four of a book that has info about James Stubbs, his siblings, his father, and grandfather from early 1700's to early 1800's in North Carolina.

Jane believed that Richard Stubbs of Hyde County, NC was probably the father of our Thomas Stubbs (I) who first appeared in NC records in 1720 and the father of John Stubbs who first appeared in Bladen County, NC in 1749 and who sold Stubbs Hyde County land in 1759. The only appearance we have of Richard Stubbs in Hyde County, NC is his signature on an undated petition made there around 1709. From 1711 to 1713 Eastern North Carolina suffered through the bloody and destructive Tuscarora Indian War. Richard Stubbs may have died in that conflict.

In 1729 James Fortner of Hyde County, NC left to Joanna Stubbs of Hyde County, 100 acres of land near Durins Point. In 1736 Joanna Stubbs administered the estate of her deceased son Richard Tayler. This gives us the information that Joanna had been married to a Tayler prior to her marriage to a Stubbs. In 1759 John Stubbs of Bladen County, NC, came to Hyde County and sold the land James Fortner had left Joanna Stubbs in his 1729 will. John Stubbs had to be Joanna's closest living relative to sell her land. He was probably her son.

A 2007 DNA comparison between descendants of John Stubbs of Bladen County, NC and of Thomas Stubbs (I) of Tyrrell County, NC shows a very close match. Both Thomas Stubbs (I) and John Stubbs of Bladen County, NC named sons Richard. This adds support to our theory that Richard Stubbs of Hyde County was father of Thomas Stubbs (I) of Tyrrell County, NC and of John Stubbs of Hyde and Bladen Counties, NC.

From Thomas and Mary Everett Stubbs

Thomas Stubbs (b.1695-98) purchased land in Chowan County, NC in 1720.

He married Mary Everett in 1721. Both died in Beaufort County, NC in 1738. Thomas and Mary Everett had five sons (according to exchange between JSB and UK Jane). Thomas and all of the sons were able to read and write. Thomas and all of his children were born and died in NC.

William b.ca. 1721 – d. 1795 (left a will)

Children: William, Samuel, Mary, Hannah, Esther, Winnea, and Sarah

Thomas, II, was born ca.1723 in Chowan, NC. He married but we do not know the name of his wife. He did not leave a will. He died about the time part of Tyrell County, NC, where he lived, became Washington County. Washington County's wills were burned and not available.

John, born ca.1725 – d. 1790 in Chowan, NC, may have married Sarah Walk.

Jane Stubbs Bailey's notes:

The father of Thomas Stubbs's wife, Mary Everett, was Nathaniel Everett. Her mother's father was William Mitchell. Thomas Stubbs called himself a planter. It was a term to designate land ownership. The first son, William, called himself a yeoman in his early land deeds. The other sons called themselves "planter." When Thomas and Mary died in 1738, Mary's father Nathaniel Everett became the guardian of the children.

Levi Stubbs, the son of Thomas, II, was born ca.1760 in Tyrell County, NC.

He m. Bathsheba Jackson. Their son, Amariah was born in 1811 in Beaufort CO, NC. He m. Frances Woolard. Their son, Robert T. was born in 1847 in Beaufort CO, NC. He m. Martha Gurkin. Their son, Robert L. was born in 1886 in Beaufort CO, NC. He m. Nellie Waters.

What follows is an integration of the work of Jane and Robert.

Thomas Stubbs II (c1723-1800) Wife's name is unknown. Tyrell County, NC Jane wrote: We do not have a will for this Thomas. He died at about the time the part of Tyrell County where he lived became Washington County. Washington County's wills were burned.

Levi Stubbs (c1760 -1817) m. Bathsheba Jackson Tyrell, Washington and Beaufort Co, NC. Bathsheba Jackson, daughter of Eleazar and Mary Jackson.

Widow Bathsheba (Jackson) Stubbs married as her 2nd husband Arnet Waters.

Amariah Stubbs (1811-1862) was born in Beaufort County, NC and died in Washington County m. Frances Woolard (c1818- 1891) – Their children included:

From Robert Stubbs:

Irving's sister, Jane had earlier researched the ancestry of Marcellus Stubbs. Jane found that Marcellus is a son of Amariah Stubbs and Francis Wollard. Amariah is also the ancestor of Irving and Jane. Jane's research is at the Gurkin family site:

Robert Stubbs supplemented some of Janes' research with additional information including the descendants of Marcellus mostly from census records.

MARCELLUS⁵ STUBBS (*AMARIAH*⁴, *LEVI*³, *THOMAS* (*II*)², *THOMAS*¹) was born Nov 1852 in NC, and died 1924 in Williamston, NC. He married (1) ELIZABETH BOYD, daughter of BOYD and MARTHA. She was born Abt. 1855 in NC, and died Bef. 1900. He married (2) MAGGIE HODGES Abt. 1904, daughter of HODGES and MARTHA. She was born Abt. 1882 in NC.

Marcellus Stubbs [a son of Amariah and Frances Woolard Stubbs] sold 50 acres of land in Bft to Levi Stubbs Jr. The land was formerly owned by Benjamin Gurkin and was willed to his daughter Lovee Davis during her life and known and described as the Charles Moore land adjoining the lines of Amariah Stubbs [Bft DB 60, 295] According to the 1880 census, Marcellus Stubbs was a farmer.



Jane found additional relatives who descended from John Stubbs, son of Thomas and Mary Everett Stubbs. One, who expressed reluctantance to be included on our website, had invested in 37 DNA markers as had Irving and this seems a large enough number to make good comparisons. He and his relatives had excellent proof of family from copies of a family Bible.

Jane saw the entries in that Bible. In that Bible was the name of James Stubbs who had disappeared from our family's records after the 1810 census. From this family's records, Jane learned that James had a son named George whose wife's maiden name could be found in Martin County, NC, the county next to Washington County, NC where James had lived for a number of years.

Wade Stubbs of Lincolnton, NC. traces his ancestors to a Seth Witherell Stubbs mentioned in Marjorie Anne Stubbs Heaney's "The Descendants of Richard Stubbs, 1619-1677 of Hull, Mass." She puts Seth born in 1807 in Leeds Maine and who moved to Lincoln, NC in 1850. Wade reports that Seth was his great-great grandfather from whom C.F. Stubbs was Wade's great grandfather, from whom William E. Stubbs was his grandfather from whom W.E. Stubbs, Jr. was his father. His family all lived in Cleveland and Lincolnton counties in North Carolina.

Robert Stubbs is one of the participants in the Stubbs DNA project. He is a descendant of the Quaker branch of the Stubbs family. Through his efforts we learned that Irving and Joseph Truman Stubbs' DNA is a 34 out of 34 match to a Stubbs male who claims descent from a Stubbs family in Cheshire. We believe that he descends from John Stubbs, son of Thomas and Mary Everett Stubbs. Joe Stubbs (Joseph Truman Stubbs from Savannah, GA) descends from Everett Stubbs, son of Thomas and Mary Everett Stubbs. Irving Stubbs and all of us descend from Thomas Stubbs (II), son of Thomas and Mary Everett Stubbs.

Since 2006 the DNA project has provided surprising additions and qualifications to our genealogical research. We learned that the DNA of our branch of the Stubbs family does not match that of descendants of the Stubbs family of Gloucester County, VA. William Carter Stubbs' 1902 research seemed logical at that time, but new DNA research has given us different tools to use in tracing family relationships.

Prior to the Revolutionary War, another branch of the Cheshire, England Stubbs' came to Florida. During the war they were loyal to England. After the war's end, they left our country for the Turks and Caicos Islands.
